RESEARCH POLICY SERIES POLICY AND PROCEDURE STATEMENT ON RESPONSIBLE CONDUCT OF RESEARCH (RCR) AT MISSISSIPPI STATE UNIVERSITY

INTRODUCTION

Mississippi State University is dedicated to the highest standard of research integrity through the responsible and ethical conduct of all those involved in research. The University is also concerned to protect the health, safety, rights and account freedom of researchers and the reputation of the University as a center for property conducted, high quality research. This policy is written to forward those ends, and to comply with the legitimate requirements of outside research funders and compositions.

PURPOSE

The purposes of Responsible Conduct of Research (RCR) raining are to promote the responsible conduct of research, and to discourage research misconduct and questionable research practices, through education.

Core areas defined for instruction include data acquisition, management, sharing and ownership; mentor/trainee responsibilities to plication practices and responsible authorship; peer review; collaborative science; research misconduct; conflict of interest and commitment, human subjects, and presearch involving animals.

DEFINITIONS

The terms used in this pelily statement are defined as follows:

Responsible Conduct of Research (RCR) is defined as the practice of scientific investigation with integrity. It involves the awareness and application of established professional names and ethical principles in the performance of all activities related to scientific recearch.

Research Misconduct is defined as fabrication, falsification, or plagiarism in proposing, performing or reviewing research, or in reporting research results (see http://ci.hhs.gov/documents/42 cfr parts 50 and 93 2005.pdf). Research Misconduct, however, does not include honest error or honest difference of opinion.

Fabrication is defined as making up data or results and recording or reporting them.

Falsification is defined as manipulating research materials, equipment, or processes, or changing or omitting data or results such that the research is not accurately represented in the research record.

Plagiarism is defined as the appropriation of another person's ideas, processes, results, or words without giving appropriate credit.

POLICY

Everyone carrying out research functions under the auspices of Mississippi State University, whether their current place of work is within or outside University premises, is expected to uphold and promulgate the highest professional standards of science that exemplify responsible practices and maintain society's trust in the scientific enterprise. This includes, but is not limited to, all faculty, staff, visiting researchers, individuals with honorary posts, and registered students. It is the responsibility of the principal investigator and co-PIs on a research project to ensure that all research eraminational research project are aware of and comply with this policy, as well as other a policable federal, state and University laws, rules, regulations, guidelines, policies and procedures.

FEDERAL AGENCY RCR TRAINING REQUIREMENTS

Training in the RCR is required of research project personnel who are being supported by funds from the following federal agencies.

PROCEDURE FOR RCR TRANING

MSU recognizes that instruction in responsible conduct of research occurs formally and informally in educational settings and that informal instruction occurs throughout the research training experience. The procedures provided below are directed at formal instruction in responsible conduct of research. It reflects the accumulated experiences and the post practices of the scientific community over the past two decades. These practices have been incorporated into many of the best regarded programs of instruction in responsible conduct of research.

I. Method of Delivery

MSU, along with the federal agencies, encourage substantial face-to-face discussions among the participating trainees/fellows/scholars/participants; a combination of didactic and small-group discussions (e.g. case studies); and participation of research training

faculty members in instruction in responsible conduct of research. While on-line courses can be a valuable supplement to instruction in responsible conduct of research, online instruction is not considered adequate as the sole means of instruction.

II. Principal Investigator/Co-PI Responsibilities

Compliance with the requirements for providing instruction in RCR is a responsibility of the Principal Investigator (PI) and Co-Principal Investigator(s). Each solicitation for funding should be reviewed to determine if RCR requirements apply. Each award notice should be reviewed to determine if there are any RCR reporting requirements. The PI/Co-PIs should communicate to project personnel, the RCR requirement, and how to complete the requirement. The PI/Co-PIs are responsible for monitoring compliance. Documentation of in-person RCR training that has been completed to satisfy the RCR requirement is a responsibility of the PI/Co-PIs unless the training is bying tracked by the Office of Research Compliance (ORC) (all online training and the sessions sponsored by ORC will be tracked in the ORC database). The 2 must take corrective action if individuals do not complete the RCR training requirement within the specified timeframe of training completion.

Willful non-compliance on the part of any project personnel shall result in termination of that person's funding.

III. RCR Training Requirements

A. Principal Investigator Co-Pls:

The PI/Co-PIs on funded NSF, NH, and USDA-NIFA proposals must complete the MyCourses "What is RCR?" course and the CITI (https://www.citiprogram.org) online RCR training before Sponsored Programs Administration will release an award.

The PI/Co-PIs must ensure that within the first 12 months of the grant period in which other personnel are assigned to the project, each individual complete the CITI online RCR training and attend 4 face-to-face sessions OR enroll in a face-to-face credit course.

The Principal Investigator and Co-PIs on funded NSF, NIH, and NIFA proposals must complete he requirements for RCR training outlined above <u>before</u> Sponsored Programs Advinctration will release an award.

The Principal Investigator and Co-PIs will receive notification from Sponsored Programs Administration and the Office of Research Compliance regarding this training requirement upon the submission of a proposal.

B. Other Project Personnel:

Project personnel on funded NSF, NIH, and NIFA proposals other than Principal Investigators and Co-PIs must complete the following RCR training requirement via one of three options listed below:

- 1) CITI online certification in RCR plus attendance at 4 one-hour face-to-face sessions covering ethical issues (8 sessions for NIH projects); or
- Enrollment in an approved 1-hour credit course in Research Ethics plus completion of the CITI online certification; or
- 3) Enrollment in an approved face-to-face 3-hour credit course in Research Fixes

C. <u>Course Information</u>:

A current schedule of face-to-face sessions can be found on the Circo of Regulatory Compliance (ORC) website (http://orc.msstate.edu/conduct/tra.vi.g/). These sessions are discussions of ethical issues associated with one of the nine core competencies recognized by the Public Health Service (PHS) Policy or instruction in the Responsible Conduct of Research. These sessions will be facilitated by thics professionals at MSU.

A listing of all approved 1-hour and 3-hour credit courses can be found on the ORC website. The courses have been determined gath tactory to meet the requirement of a program of study designed to contribute to the knowledge and respect of high ethical standards. A passing grade is required for the course to be counted as RCR training. Anyone wishing to enroll in credit courses should contact the MSU Registrar's Office.

Project personnel who are require to do so must complete the on-line CITI training component within the first 90 days of appointment to a covered project. The face-to-face training component must be completed within the first 12 months of appointment to a covered project.
